Reports

Dr. Isoye reported that 1) More than two hundred seniors—or roughly 25% of the class of 2015—have been named 2015-2016 State Scholars for outstanding academic achievement. To qualify, students had to perform in the top half of their high school class at the end of junior year and/or score in the 95th percentile on the ACT or SAT; 2) Former head wrestling coach Mike Powell, who has been chosen as a 2015 inductee to the National Wrestling Hall of Fame. 3) Several students took top honors in the Illinois Music Educators Association competition for original composition. First place awards went to Evan Thompson for jazz improvisation and Reiny Rolock for keyboard solo. Stephanie Carlin won second in vocal ensemble, and Reiny Rolock took third in instrumental-solo to chamber ensemble. 4) 12 students have been chosen to perform at the IMEA's All-State Festival. Thousands of high school musicians auditioned, with only the top 5% advancing to the all-state level. Kudos to Gabe Girson, Anna Holden, Sage Pope, Rory Schrobilgen, Thomas Barlow, David Messina, Fiona Ryan, Mathias Pergams, Jacob Schaider, Mary Martin, Max Lazarus, and Evan Thompson; and 5) OPRF has been awarded \$20,000 in money for students to study abroad next summer! The award comes from the Council on International Educational Exchange, and freshmen, sophomores, and juniors are eligible to apply for experiences in 13 different countries.

A public hearing was held on the Tax Levy. Updates were given on the Swimming Pool Site Committee and the History Division. A debrief of the student discipline retreat was held on December 6. Strategic Plan Implementation Chairs presented.
